Attention LVSOA Official...

FYI -- for those of you who will be working this year's postseason tournaments, please be aware of the following rule interpretation.

In response to a question raised during our last chapter meeting Sunday night, we have received the following clarifications from PIAA pertaining to how the new yellow card "sit out" rule is to be enforced if a player receives a yellow card during the penalty kick tiebreaker.

Some background info:

- The misconduct procedures are outlined in the 08/09 rulebook on page 84. Scenario #2 in PIAA's note below supersedes section 1, a, (1) in the rulebook; all of the other scenarios appear to be consistent with the rulebook.
- Understandably, the odds are low that we'll encounter any of these scenarios during the penalty kick tiebreaker. But...this is one of those "just in case" situations where we want to make sure we have the correct information at the ready.

Dr. Lombardi and Mr. Donnangelo would like you to have the following:

Scenerio #1

Player receives yellow card prior to kicking in first set of PK.

Ruling: Player does not participate in first set of PKs but may participate in second set.

Scenario #2

Player receives yellow card after taking PK.

Ruling: Cannot participate in second or third set of PKs.

Scenario #3

Goaltender receives yellow card before shot taken in first set of PKs.

Must sit out that shooter. May return for next shooter.

Scenario #4

Goaltender receives yellow card in first set after shot taken.

Ruling: Must sit out subsequent shooter. May return after one shooter sit out.

Scenario #5

Goaltender receives yellow card in second set of PKs.

Ruling: Must sit out one shooter and may return for the subsequent shooter.
